## APPLICATION PROCESS AND GUIDELINES FOR OBTAINING CERTIFICATE OF OCCUPANCY IN KOGI STATE

Under the Governor of Kogi State Executive Order Number 03 of 2022, Establishing Kogi State Geographic Information System Agency and the Kogi State Internal Revenue Service Regulation on Trade-Related Fees and Levies for Inter-State Movement of Goods, 2022, individuals and companies can apply and obtain a CofO from the Kogi State Geographic Information System Agency by following the guidelines below:

7	Applicants are notified via phone call or text messages, and they will then visit the CRGIA office to collect the Certificate of Occupancy.	1 day	No cost
