(APRROPRIATION LAW 2020)

Title

Date of Commencement

1ST JANUARY 2020

Be it enacted by the Kogi State House of Assembly and by Authority if the same as follow:

Enactment

- 1. This Law may be cited as the Kogi State appropriation Law 2020.
- 2. The Sum not Exceeding:
- (a) Seventy Eight Billion, Nine Hundred and SixtyNineMillion, One Hundred and TwentyEight Thousand, Seven Hundred and Thirty Seven Naira (₹78,969,128,737) only shall be Appropriated from the consolidated Revenue Fund of the Kogi State for the Recurrent Expenditure of the State Government during the year ending 31st December, 2020 as set out in the first schedule to the Law.
- (b) Ninety Seven Billion, One Hundred and Fifty Second Schedule ThreeMillion, Nine Hundred and SixtyThreeThousand, One Hundred and Ninety FourNaira (N97,153,963,194) only shall be appropriated from the Consolidated Revenue Fund of KogiState Government during the year ending 31stDecember, 2020 for Capital Expenditure in the Second Schedule to this Law.
