





It is my pleasure to inform you that Kogi State has officially adopted the health sector strategy blueprints (HSSB) for her Annual operational planning (AOP) frame work/guidelines as issued by the Federal Ministry of Health and Social Welfare. This important step is aimed at streamlining the development and submission of the State's consolidated work plan for the health sector in line with the Sector Wide Approach (SWAp).


The health sector Renewal Initiative through the framework of the Health Sector Strategic Blue print (HSSBP), provides a structured methodology for planning, coordinating, and executing health programs and initiatives within Kogi State. The adoption of same is expected to enhance efficiency and alignment with National Health Priorities to improve health planning and outcomes in the state.

In addition, to the above, you are to ensure the following:

- That your work plan aligns with the Chart of Accounts by ensuring that all expenditure adhere to the approved State Chart of Accounts to facilitate budget tracking, financial reporting and fund management.
- That your annual work plan is harmonized to avoid duplication of interventions while ensuring efficiency and fiduciary discipline.
- That the recurrent Costs for Frontline Workers including the recurrent costs associated with frontline health workers, their salaries, benefits, and recruitment plans, for proper planning and sustainability should be reflected in your work plan.

Please note that through this circular, Kogi State formally adopts these guidelines in line with the sector wide approach (SWAp) for the preparation and submission of consolidated work plans for the health sector.
