Step 2 Prepare Relevant Documents	<ul> <li>Fill out the form completely and accurately and Leave NO section empty or unanswered.</li> <li>List sizes and numbers of signage, locations, and placements.</li> <li>Submit the completed form, list location, and number of signages.</li> <li>Undertakes site inspection and other evaluations of signage and follows up on the captured sign with a site.</li> </ul>	2 days	No charges
<b>Step 3</b> Site inspection and other evaluations	<ul> <li>Billing prepares invoices/demand notices based on evaluations and bills sent to signage owners via email or SMS. Note: Bills for a</li> </ul>		

	<ul> <li>particular year are prepared and sent to signage owner in the last two months of the preceding year.</li> <li>✓ Client service and Compliance serve signage owner with demand notice. Agency runs up enormous costs in serving bills to signage owners.</li> </ul>

	<ul> <li>All successful Applicants will be issued an operation permit to operate signage and advertisement in the State as a licensed signage and advertisement operator after having returned the signed Acceptance Letter with evidenceof payment of all fees to the schedule officer at the Signage office</li> </ul>
