A LAW TO MAKE PROVISION FOR THE APPROPRIATION OF FUNDS FROM THE CONSOLIDATED REVENUE FUND OF KOGI STATE FOR THE SERVICES OF THE GOVERNMENT OF KOGI STATE FOR THE YEAR ENDING 31ST DECEMBER 2025 AND FOR RELATED MATTERS

ENACTED by the Kogi State House of Assembly and by the *Enactment* authority of same as follows:

- **1.** This Law may be cited as the Kogi State Appropriation Law, *Citation* 2025.
- **2.** The Law shall come into force on the First Day of January *commencement*. 2025.
- **3.** In this law unless the context otherwise requires:

Interpretation.

- "2025 fiscal year" means the period beginning from January 1, 2025, and ending in December 31, 2025;
- "Accountant-General" means the Accountant-General of Kogi State;
- "Appropriation Law" means the Kogi State Appropriation Law for the year ending 31st December, 2025;
- "Assembly" means the Kogi State House of Assembly;
- "Commissioner" means the Commissioner in Charge of Finance:
- "Consolidated Revenue Fund" means the Consolidated Revenue Fund of Kogi State;
- "MDAs" means Ministries, Departments and Agencies of Kogi State Government; and
- "State" means Kogi State of Nigeria.
- 4. (1) The total sum of N582,404,119,489.00 (Five Hundred and Eighty-Two Billion, Four Hundred and Four Million, One Hundred and Nineteen Thousand, Four Hundred and Eighty-Nine Naira only) is hereby appropriated as estimate of revenue (recurrent revenue

and capital receipt as set out under Schedule to this Law) into the Consolidated Revenue Fund of Kogi State.

(2) The total sum of N582,404,119,489.00 (Five Hundred and Eighty-Two Billion, Four Hundred and Four Million, One Hundred and Nineteen Thousand, Four Hundred and Eighty-Nine Naira only) is hereby appropriated from the Consolidated Revenue Fund of Kogi State for the services of the Government of Kogi State for the year ending 31st December 2025.

First Schedule

5. (1) The amount specified in the Schedule to this Law shall be issued and applied for the purposes detailed therein.

Allocation of funds.

Second Schedule

- (2) The Sum Not Exceeding:
 - Eighty-One Billion, One Hundred and Twenty-Three Million, Two Hundred and Fifteen Thousand, Six Hundred and Eighty-Seven Naira only) shall be Appropriated from the Consolidated Revenue Fund of Kogi State for the Recurrent Expenditure of the State Government during the year ending 31st December 2025 as set out in the Second Schedule to this Law.

Third Schedule

(b) N301,280,903,802.00 (Three Hundred and One Billion, Two Hundred and Eighty Million, Nine Hundred and Three Thousand, Eight Hundred and Two Naira only) shall be appropriated from the Consolidated Revenue Fund of Kogi State Government during the year ending 31stDecember, 2025 for Capital Expenditure as set in the Third Schedule to this Law.





6. (1) No funds shall be expended without proper authorization and in accordance with existing financial regulations.

Expenditure control.

- (2) Any expenditure not covered by this Appropriation Law shall require supplementary appropriation.
- 7. The Commissioner for Finance shall be responsible for the implementation of this Law, and the Assembly shall exercise oversight to ensure compliance.

Implementation and oversight.

8. (1) The details as set out under the Fourth Schedule to this Law shall be the summary of recurrent and capital revenue allocations from the MDAs and the total amount therein is hereby appropriated into the Consolidated Revenue Fund of Kogi State for the year ending 31st December 2025.

Fourth Schedule.

Allocations to MDAs.

(2) The details as set out under the Fifth Schedule to this Law shall be the summary of expenditure allocated respectively to the MDAs and the total amount therein is hereby appropriated from the Consolidated Revenue Fund of Kogi State for their respective services for the year ending 31st December 2025.
